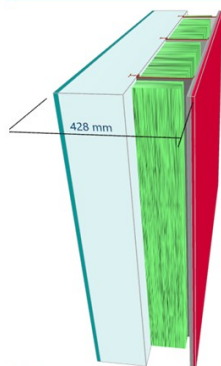

Predicting of sound insulation

Technical and Test Institute for Construction Prague, SOE, member of EUROLAB-CZ, is now improving services in the field of sound insulation predictions. The purchased software allows predictions of the sound insulation of walls, floors, roofs, ceilings and windows; impact sound and rain noise of floors and roofs.

The programme can be used to quickly evaluate new materials and systems, or to investigate the effects of changes to existing designs. It models materials using well known elastic plate theory including allowances for thick panel effects as published by Ljunggren, Rindell and others.

Visit to the Turkish Ministry of Agriculture and Forestry

On February 26, 2020, Halit Karaboğa, Chairman of the Board of Directors of TURKLAB, Sabahnur Demirci, Vice Chairman of the Board, Çağatay Turan, Secretary General, and Pinar Akalın, Communication Committee Chair, visited Mr. Harun Seçkin, General Director of Food and Control at the Ministry of Agriculture and Forestry, and Mr. Ali Torun, Head of the Department of Laboratories, in their office. During these meetings, lots of suggestions were brought up and TURKLAB's opinions were asked in relation to the new regulations and analysis on behalf of our members.

Visit to the Turkish Ministry of Environment and Urban Planning



On February 27, 2020, Halit Karaboğa, Chairman of the Board of Directors of TURKLAB, Murat Hacıömeroğlu, Environmental Committee Chair, and Arzu Ballıkaya, Communication Committee Chair, visited Mr. Ercan Gülay, Turkish Ministry of Environment and Urban Planning General Director of Environmental Impact Assessment, Permit and Inspection, Mr. Soner Olgun, Head of Department of Environment Reference Laboratory, Mrs. Nazan Özyürek, Head of Air Management Department, and Mr. Muhammet Ecel, General Director of Environmental Management, in their office.

Mr. Ercan Gülay was informed about the Board of Directors of TURKLAB, who will serve for 2020-2021 period, and conversations were held about the MELBES system.

Also, negotiations were held with Mr. Soner Olgun on the MELBES system, and we were told that the results of the Second Central Laboratory Identification System



(MELBES) Workshop, held in Antalya, would be announced soon. During the meetings, it was also stated that the establishment of a new laboratory would not be allowed, and the device and scope would not be increased.

The opinions of Mr. Muhammet Ecel were asked on the abolishment of the "Regulation on Waste Oil Management" published on 21.12.2020. It was commented that waste oil recycling companies would be taken over in this process, and their numbers would decrease in one year. It was mentioned that oil group analysis could be carried out within the companies themselves.

During the visit to Mrs. Nazan Özyürek, the draft "Regulation on the Control of Industrial Air Pollution" to be issued was discussed. And she told which R&D studies were carried out and what kind of functions they performed in this process.

On March 03-05, 2020, Çağatay Turan, Food Committee Chair, and the members of the Food Committee, namely Sabahnur Demirci, Tuncay Çınar and Ali Bahadır Çelik came together with the representatives of the Department of Food Control and Laboratories of the Ministry of Agriculture and Forestry at the workshop on the draft "Regulation on Private Food Control Laboratories" organized at the Hotel Büyük Abant by TURKLAB and the Ministry.

The study TURKLAB prepared in line with the opinions and suggestions of their members regarding the "Regulation on the Establishment, Duties, Authorities and Responsibilities of Food Control Laboratories and Determination of Working Procedures and Principles" was discussed and evaluated. It was a highly productive workshop for the industry.

IAF

- IAF sent a call for nomination(s) for the Position of IAF Director Representing CAB Association Members (2020 - 2022). Two nominations have been received for the IAF Quality Manager position:
 - ⇒ Mr. Pedro Alves
 - ⇒ Mr. Mario Andrade Castro
- The Results of the 30-Day Ballot – **Joint IAF-OIML Assessment Procedure in the Field of Legal Metrology** were published. The result of the ballot is valid. 77 Members voted in favour of the document, 0 voted against, and 16 abstained. Accordingly, the vote passed.
- The IAF Technical Committee (TC) is submitting a proposal to withdraw **IAF ID 9: 2015 Transition Planning Guidance for ISO 9001:2015**, **IAF ID 10: 2015 Transition Planning Guidance for ISO 14001:2015**, and **IAF ID 11:2015 Information on the Transition of Management System Accreditation to ISO/IEC 17021-1: 2015** from ISO/IEC 17021: 2011 to all IAF Voting.
- The IAF-ILAC Mid-Term Meetings planned to be held in Beijing on 30 March - 06 April 2020 were cancelled. The **IAF/ILAC Joint Executive Committee has agreed to not proceed with re-scheduling the Joint Mid-Term Meetings**. This decision was made based on a number of factors, including the difficulty in re-organizing the meetings in such a limited time frame, the global uncertainty around the future spread of the coronavirus, the potential scheduling and budgetary issues for IAF and ILAC Members as a result of moving the meetings and the current level of fluidity around flight and other travel restrictions.
- IAF sent out a **summary report proposing that IFS Management GmbH (IFS) be admitted to membership in IAF**. The IAF Board and Executive Committee have reviewed the report in support of the application and the Board has recommended that the IAF members vote in favour of inviting IFS to join IAF as an Association Member.

- The draft minutes of the 19th IAF/ILAC Joint General Assembly, held in Frankfurt on 29 October 2019, have been distributed.
- Result: 30-Day Ballot - **IAF/ILAC-A1:XX/202X – IAF/ILAC Multi-Lateral Mutual Recognition Arrangements (Arrangements): Requirements and Procedures for Evaluation of a Regional Group** - 75 Accreditation Bodies and 19 Association Members had voted, which means a quorum existed; 86 Members voted in favour of the document, 0 voted against, and 8 abstained. Accordingly, the IAF vote passed.
- Result: 30-Day Ballot – **IAF/ILAC-A3:XX/202X – IAF/ILAC Multi-Lateral Mutual Recognition Arrangements (Arrangements): Template report for the peer evaluation of an Accreditation Body based on ISO/IEC 17011:2017** - 76 Accreditation Bodies and 19 Association Members had voted, which means a quorum existed. 86 Members voted in favour of the document, 1 voted against, and 8 abstained. Accordingly, the IAF vote passed.

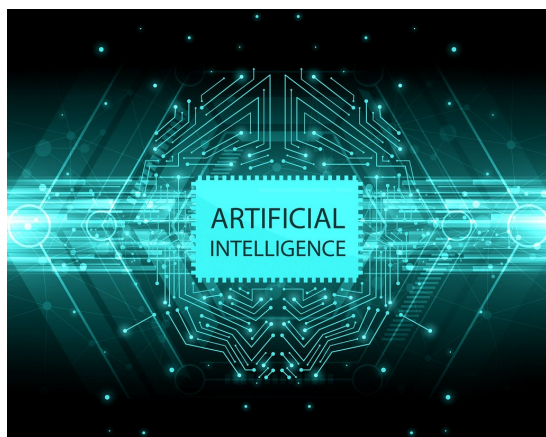

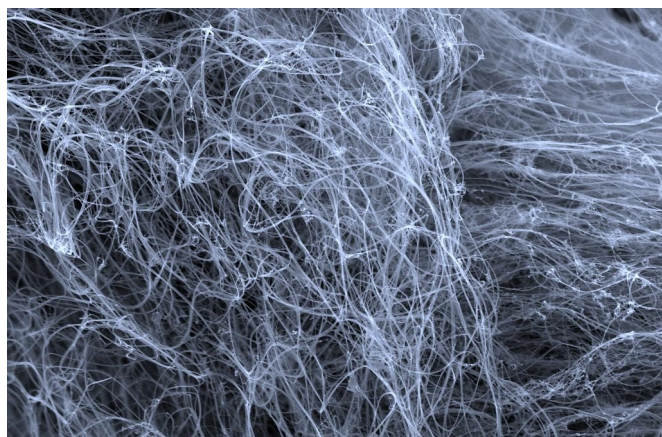

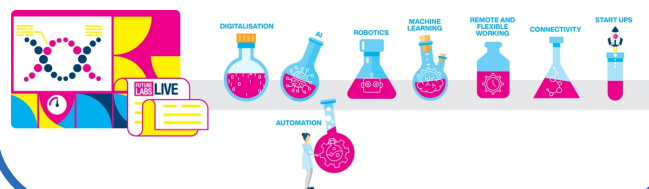

- The European Commission adopted a new [Circular Economy Action Plan](#) - one of the main building blocks of the [European Green Deal](#), Europe's new agenda for sustainable growth. With measures along the entire life cycle of products, the new Action Plan aims to make our economy fit for a green future, strengthen our competitiveness while protecting the environment and give new rights to consumers. Building on the work done since 2015, the new Plan focuses on the design and production for a circular economy, with the aim to ensure that the resources used are kept in the EU economy for as long as possible. Counterfeit products

- The European Commission launched a public consultation on [counterfeit products and piracy](#). The consultation will remain open until 12 May.
- **White House Releases Long-Awaited Counterfeiting Report, Calls for Increased Liability for E-Commerce Platforms:** As first reported by [the Wall Street Journal \[jiz4.me\]](#) and [Reuters \[jiz4.me\]](#), the White House, in conjunction with the Department of Homeland Security, has finally released their long-awaited report on the ever-growing issue of counterfeits. Of note, the report paints a scathing picture of e-commerce platform's unwillingness to police their platforms to prevent the sale of fake goods from third parties, calling for greater government scrutiny and penalties if they don't take serious steps to stem the tide of fakes. Specifically, the report says law enforcement will begin identifying cases immediately and "seek all available statutory authorities to pursue civil fines and other penalties against these entities."
- **We bought dozens of products from AliExpress, Amazon, eBay, Walmart and Wish. Over half were suspected fakes:** It's quick, convenient and ships right to your front door. But a *Marketplace* investigation found that you can't always trust what you purchase online — even if the seller, platform or price seems legit. To test how prevalent counterfeits are online, *Marketplace* purchased dozens of well-known products — ranging from electronics to sportswear to cosmetics — from five popular online retailers: AliExpress, Amazon, eBay, Walmart and Wish. Each product listing seemed legitimate, with some prices that compared to retail stores and official-looking advertisements. More than half of the products *Marketplace* received were suspected or confirmed counterfeits, with knockoffs found on every platform. And in some cases, *Marketplace* found that the risk of ending up with a knockoff might be more than just a financial hit. 66% of products tested from online marketplaces AliExpress, Amazon Marketplace, eBay and Wish failed safety tests. New research has revealed that a staggering 66% of the 250 products bought from online marketplaces have failed safety tests. We've spent the past year working in collaboration with five other European consumers' associations to test products sold through online marketplaces such as AliExpress, Amazon, eBay and Wish to see how safe they are. We can report that two out of three of the products tested – or 165 products in total – didn't pass relevant safety tests. [Read more.](#)
- **The dangerous world of recalled and counterfeit cosmetics:** the U.S. law doesn't require FDA approval for cos-

metics and most ingredients, But the FDA does do spot tests, and the administration has found asbestos in some make-up over the last year. After the results of these tests, it recommended consumers stop using certain make-up products. A company that tested the products on behalf of the FDA found asbestos in the cosmetics, and companies then made voluntary recalls. [To can see the products that have been recalled over the last year, you can click here.](#) They included several Beauty Plus Global Products, make up marketed toward children, and Claire's make-up palettes. In October, Johnson's baby powder was also voluntarily recalled after certain containers tested positive for asbestos, according to the FDA. The issue is that asbestos is a naturally occurring mineral that is often found near talc. The FDA says talc is a common ingredient in many cosmetic products. [Read more.](#)

- The [Eurobarometer](#), a survey for Europeans' perceptions, showed support for data sharing and sustainability.
- **E-privacy:** The Council's presidency published [amendments](#) to its proposal for a compromise on the draft Regulation.
- **Secure 5G networks: Commission endorses EU toolbox and sets out next steps:** On January, 29th, 2020, The Commission endorsed the joint toolbox of mitigating measures agreed by EU Member States to address security risks related to the rollout of 5G, the fifth-generation of mobile networks. This follows the European Council's call for a concerted approach to the security of 5G and the ensuing Commission Recommendation of March 2019. Member States have since identified risks and vulnerabilities at national level and published a joint EU risk assessment. Through the toolbox, the Member States are committing to move forward in a joint manner based on an objective assessment of identified risks and proportionate mitigating measures. With its Communication adopted, the Commission is launching relevant actions within its competence and is calling for key measures to be put in place by 30 April 2020. [Read more.](#)
- **Shaping Europe's digital future: Commission presents strategies for data and Artificial Intelligence:** The Commission has unveiled its [ideas and actions](#) for a digital transformation that works for all, reflecting the best of Europe: open, fair, diverse, democratic and confident. It presents a European society powered by digital solutions that put people first, opens up new opportunities for businesses, and boosts the development of trustworthy technology to foster an open and democratic society and a vibrant and sustainable economy. Digital is a key enabler to fighting climate change and achieving the green transition. The European [data strategy](#) and the policy options to ensure the human-centric development of [Artificial Intelligence](#) (AI) presented today are the first steps towards achieving these goals. Digital technologies, if used with purpose, will benefit citizens and businesses in many ways. Over the next five years, the Commission will focus on three key objectives in digital:
 - ⇒Technology that works for people;
 - ⇒A fair and competitive economy; and
 - ⇒An open, democratic and sustainable society.
- **Introducing the OECD Artificial Intelligence Policy Observatory:** In May 2019 the OECD adopted its [Principles on Artificial Intelligence](#), the first international standards agreed by governments for the responsible stewardship of trustworthy AI. The OECD Principles on AI include concrete recommendations for public policy and strategy. The general scope of the Principles ensures they can be applied to AI developments around the world. In our recent report [Artificial Intelligence and Society](#), a chapter on [public policy considerations](#) reviews salient policy issues that accompany the diffusion of AI. It supports the value-based OECD Principles on AI and outlines national policies to promote trustworthy AI systems. The [OECD.AI Policy Observatory](#), launched in February 2020, aims to help policy-makers implement the AI Principles. [Read more.](#)

Environment

- **Transport:** Mobility associations published a [joint position paper](#) on the EU's Green New Deal.
- **Renewable energy share in EU reaches 18 percent:** The share from renewable sources in energy consumption in the EU reached 18 percent in 2018, up from 17.5 percent a year earlier, Eurostat said Thursday. The EU's target is to reach 20 percent by 2020, and 12 member states have already reached their national binding targets. Sweden has the highest share with 54.6 percent and the Netherlands has the lowest with 7.4 percent. [Read more.](#)
- **Committing to climate-neutrality by 2050: Commission proposes European Climate Law and consults on the European Climate Pact:** The Commission presents a proposal to enshrine in legislation the EU's political commitment to be climate neutral by 2050, to protect the planet and our people. The European Climate Law sets the 2050 target and the direction of travel for all EU policy, and gives predictability for public authorities, businesses and citizens. At the same time, the Commission is launching a public consultation on the future European Climate Pact. Through this consultation the public will be involved in co-designing this instrument. With the European Climate Law the Commission proposes a legally binding target of **net zero greenhouse gas emissions by 2050**. The EU Institutions and the Member States are collectively bound to take the necessary measures at EU and national level to meet the target. The Climate Law includes **measures to keep track of progress and adjust our actions accordingly**, based on existing systems such as the governance process for Member States' National Energy and Climate Plans, regular reports by the European Environment Agency, and the latest scientific evidence on climate change and its impacts. Progress will be reviewed every five years, in line with the global stock take exercise under the Paris Agreement. [Read more.](#)

Food

- The Official Controls Regulation entered into force in December 2019. See an assessment [here](#).
- The European Commission published for public commenting a [roadmap](#) highlighting the main goals of its upcoming "**Farm to Fork Strategy**". According to the roadmap, the strategy will include measures:
 - ⇒ To reduce the use and risk of chemical pesticides
 - ⇒ To reduce the use of fertilizers and antibiotics
 - ⇒ Actions seeking an improvement of animal welfare
 - ⇒ To improve food information such as on where the food comes from and its nutritional value.
- The European Commission launched a [consultation](#) regarding legislation on food irradiation. The consultation will remain open until 25 May.
- The European Commission launched a [consultation](#) on a draft act permitting under conditions hydroxyanthracene derivatives in food supplements. The consultation will remain open until 1 April.
- Euractiv, an EU-focused media outlet, published an [article](#) based on a leak of the upcoming farm-to-fork strategy.

Medical devices

- The Medical Devices Coordination Groups is expected to discuss on 11 and 12 march a joint implementation plan of the Medical Devices Regulation and In Vitro Medical Devices Regulation. So far, 11 notified bodies (NBs) have been designated under the new Regulation (and 3 under IVDR). Recently two NBs were officially notified in the NANDO database under the MDR. These are DNV GL Presafe AS ([NB#2460](#)) and the National Standards Authority of Ireland (NSAI) ([NB#0050](#)).
- **The impact of the new EU AI & Data strategies' on digital health:** The European Commission published on 19 February 2020 the [European Strategy for Data](#) and the [White Paper on Artificial Intelligence: a European Approach](#), under the umbrella of the [Communication on Shaping Europe's Digital Future](#), which express a commitment of the new Commission to build a data economy on the basis of European values and principles. These developments bring great potential for digital health due to substantive plans and resources for the deployment of data sharing tools and platforms, the creation of governance frameworks, and the focus on quality and interoperability of data. MedTech Europe has issued a [statement](#) on the new documents, and will participate in the stakeholder consultative process. [Read more.](#)

Trade

- **European Parliament ratifies Vietnam trade deal:** European Parliamentarians on Wednesday voted in favor of a trade agreement between the EU and Vietnam, taking the deal over its last hurdle. Some 401 MEPs voted in favor, with 192 against, according to Parliament's trade committee. The pact [pits the EU's aspirations](#) to gain a foothold in one of Southeast Asia's most important and expanding markets — with a population of 96 million — against the concerns of activists on human rights and environmental issues. Indeed, the European Parliament held off the vote until Hanoi promised to sign up to basic international labour standards. [The agreement](#) is set to enter into force in the summer, and will eliminate virtually all customs duties on exports to and from Vietnam over the next decade, with 65 percent of EU products and 71 percent of exports from Vietnam enjoying duty-free access from day one. [Read more.](#)
- On 10 February, the [Association of Southeast Asian Nations \(ASEAN\)](#) and the EU held a meeting to discuss the promotion of sustainable development in the ASEAN region through channeling development funding to sustainable transition.
- **2nd #ASEAN-EU Dialogue on Sustainable Development: Towards Achieving the Sustainable Development Goals:** The 2nd ASEAN-EU Dialogue on Sustainable Development: Towards Achieving the Sustainable Development Goals opened on 10 February in Brussels. The aim is to promote ASEAN-EU cooperation on the implementation of the [UN 2030 Agenda for Sustainable Development](#) and the Paris Agreement. The dialogue underlines political support to the sustainable development dimension of ASEAN-EU co-operation. The dialogue brings together senior officials from the EU and ASEAN to focus on climate change, green growth and financing, regional integration in inclusive and sustainable development, and gender equality and women's economic empowerment. Other participants include representatives from relevant sectoral European Parliament committee chairs, the OECD, UN agencies, from the ASEAN Centre for Sustainable Development Studies and Dialogue as well as European and ASEAN private sector representatives. - The [European Commission](#) has decided to withdraw part of the tariff preferences granted to Cambodia under the European Union's Everything But Arms' (EBA) trade scheme due to the serious and systematic violations of the human rights principles enshrined in the International Covenant on Civil and Political Rights.
- The EU Trade Commission Philip Hogan presented a new [transparency package](#) which includes the publication of:
 - ⇒The European Commission's decision authorising Member States to conduct bilateral investment negotiations

⇒Non-business sensitive summary records from the meetings of the Trade Defence Instruments Committee

⇒Commission recommendations for negotiating directives, not only for preferential trade agreements, as this is already the case, but also for non-preferential ones.

- The European Commission launched a [public commenting period](#) on its upcoming initiative to evaluate customs co-operation and mutual administrative assistance between the EU and China since the signing of the EU-China Customs Cooperation and Mutual Administrative Assistance Agreement in 2004. The roadmap is open for comments until 3 April.
- **EU, China, others agree on WTO body to settle disputes:** Seventeen World Trade Organization members, including the EU and China, agreed Friday to create a temporary mechanism to settle trade disputes after the US paralysed the WTO's appeals body last month. The contingency step would preserve the WTO's two-step dispute system until its own Appellate Body became operational again, the EU commission said. Washington froze the body, the supreme court for international trade, by blocking appointments for over two years. [Read more.](#)
- **Trump: Time to negotiate 'very seriously' with EU on trade:** President Donald Trump said Monday (10 February) the time has come to pursue trade negotiations with the European Union which he said imposes "incredible" barriers to US goods. "Europe has been treating us very badly," Trump said at a White House event with US state governors. After reaching a series of trade deals with Canada, Mexico and Japan, and a phase-one agreement with China, Trump said, "The next thing could be Europe, where we talk to them very seriously." Relations between the two major economies have lingered for months in a tense truce. Trump has imposed punishing tariffs on EU goods like French wine in disputes over steel imports or government subsidies for Airbus. [Read more.](#)

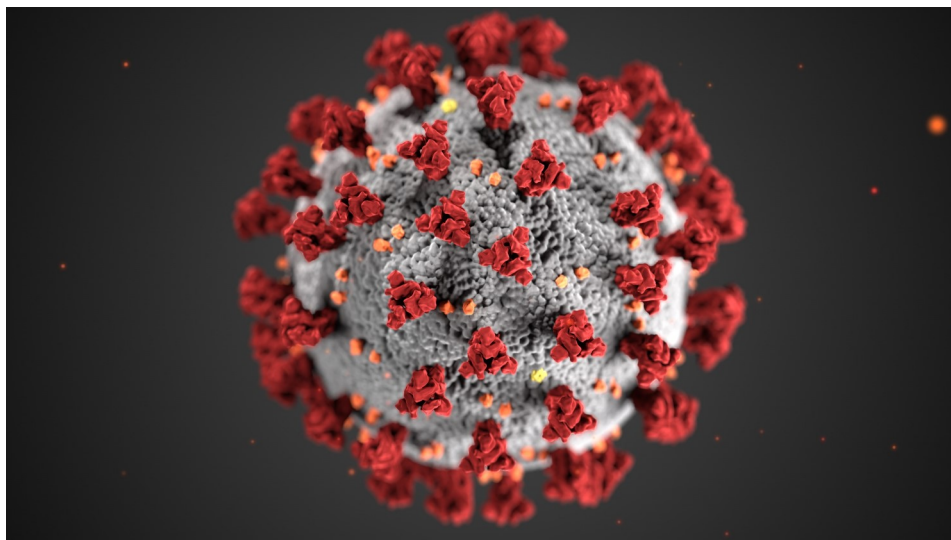
